DOG WAIVER

Notification of a dog must be acknowledged upon making reservations, with introductions at check in. Charge is \$450 per dog (plus tax); no more than two dogs are permitted during a stay. This waiver indicates you understand the rules and assume responsibility for any damages. Your signature signifies you agree to pay any additional charge for repairs and authorize the Bella Vista to charge the credit card even if they are discovered following departure (a credit card must be kept on file to cover any such expenses).

1. Dogs must be walked on asphalt or groomed areas of the Estate. All dog droppings must be picked up and disposed of by the dog owners.
2. Please pack a bed and blanket or ask us for a spare towel for your pet; do not allow dogs on furniture or beds unless covered. It is also helpful to bring something on which your dog will be comfortable sleeping.
3. Please groom your dog, particularly if it is a breed prone to shedding, as we keep our property at hypoallergenic standards.
4. Please clean and dry off your dog before entering the homes.
5. Dogs are not allowed in swimming pools or hot tubs.
6. Dog's medication and immunizations must be up-to-date with current tags.
7. Should the dog create any disturbances which cause complaints to be made to Bella Vista by neighbors, at the request of the Property Manager, dog owner shall immediately make arrangements to kennel the dog elsewhere.

Indemnification

I further agree that I shall assume full and complete responsibility for any personal injury or property damage caused by the dog(s) suffered by any guest, employees, or invitees of the Estate, including the approved veterinarian and its employees. In the event that such personal injuries or property damage should arise, I agree to indemnify, defend and hold harmless the Bella Vista Estate, together with its past or present officers, directors, employees, agents, attorneys, insurers, affiliated companies, successors and assigns for any claim which may arise.
